**Christina Sandefur
"The Right to Try"**

Christina Sandefur is Executive Vice President at the Goldwater Institute. She develops policies and litigates cases advancing healthcare freedom, free enterprise, private property rights, free speech, and taxpayer rights.

Sandefur is a co-drafter of the 'Right to Try' initiative, now law in 24 states, which protects terminally ill patients' right to try safe investigational treatments that have been prescribed by their physician but are not yet FDA approved for market. She also has won important victories for property rights in Arizona and works nationally to promote the Institute's Private Property Rights Protection Act, a state-level reform that requires government to

pay owners when regulations destroy property rights and reduce property values.

Sandefur is the co-author of the book *Cornerstone of Liberty: Private Property Rights in 21st Century America* (2015). She is a frequent guest on national television and radio, including Fox Business's Stossel, Dick Morris, and The Armstrong & Getty Show. Her litigation and policy work has been featured in National Review, The Washington Post, Human Events, The American Spectator, and The Weekly Standard, among others.



More than 135 years of precedent stand solidly on the side of delaying a confirmation in an election year until after the next president takes office. The Constitution is truly at stake.



The Making of a Nation

John Adams, the 7-hour HBO special, is one of the great stories told about the making of our nation. American history is brought to life on the screen via David McCullough's book of the same name. In his book, McCullough takes from some of the letters exchanged between John Adams and his wife, Abigail, to describe their commitment to this new experiment called 'America.' When duty called – as when Adams was sent to France requesting financial support for the American Revolution – John and Abigail's separations (sometimes years at a time) kept them connected through more than 1,100 letters. The exchange below exemplifies the hardship, the loyalty and the spirit of fighting for our freedom because of patriots like them:

Dearest John,

It feels as though we have spent a far greater portion of our marriage apart, than together. Strange how the sun rises and sets whether you be at my side or not. But in this cause we build a future – it is our legacy – freedom is the best gift we can impart to our children. We shall fight for the rights of men and women, and shall prevail against those who would deny us this agency. I possess no doubt, that with God on our side, we shall have no need to fear what mortal men can do.
